1. NAME OF MEET

Perak Invitational Age Group Swimming Championship 2018 (the "Competition")

VENUE

Akuatik Amanjaya, Perak Darul Ridzuan

3. DATE

Day #1: Friday, 20th July 2018 Time: 8.00am
Day #2: Saturday, 21st July 2018 Time: 8.00am
Day #3: Sunday, 22nd July 2018 Time: 8.00am

4. ELIGIBILITY

- 4.1 Members from affiliates of Amateur Swimming Union of Malaysia.
- 4.2 Schools/Swimming Club affiliated to Amateur Swimming Association of Perak.
- 4.3 No independent unattached swimmers are allowed.

5. ENTRY RESTRICTION

- 5.1 Individual Events no restriction on entries from each club/school/affiliate.
 - Team Events one (1) team per club/school/affiliate.
- 5.2 The relay entry forms with swimmers' names in the right order must be submitted to the Control Room before lunch break on the day of the competition.

6. COMPETITION FORMAT

- 6.1 The Competition shall follow FINA rules on swimming.
- 6.2 All events shall be held on a Time Final basis.

7. AGE GROUPS

Open	18 year and above	
Group 1	15 to 17 years	Born on 2/1/2000 to 1/1/2003
Group 2	13 to 14 years	Born on 2/1/2003 to 1/1/2005
Group 3	11 to 12 years	Born on 2/1/2005 to 1/1/2007
Group 4	9 to 10 years	Born on 2/1/2007 to 1/1/2009
Group 5	8 years and under	Born on 2/1/2009 and after

- 7.1 Swimmer are only eligible to swim in their respective age groups except for Open events whereby swimmers from Group 1, 2 & 3 are allowed to participate in the Open events.
- 7.2 For relay events, no swimmers are allowed to swim up to another age group and there are no relay events for Open category.
- 7.3 However, for relay events 233, 234, 335 and 336, which is a relay combination of swimmers from Group IV and V must consist of only two(2) swimmers from Group V per team.

9. ENTRY FEES & PAYMENT

9.1 Registration Fee: RM12.00 per swimmer

Individual Event Entry Fee: RM6.00 per event

Relay Entry Fee: RM12.00 per relay event

- 9.2 Total entries fees are payable to "Persatuan Renang Amator Perak" as per final entry checklist. Upon checklist confirmation by participating club/school/affiliate, there will be no revision or refund of the entry fees due to withdrawals/scratching at team manager's meeting.
- 9.3 The organizer reserves the right to disallow swimmers from participating in the Competition should the entry fees of the affiliate is not settled on the day of competition.
- 9.4 All entry fees must be paid prior to or during the Team Managers' Meeting in cash/cheque or online banking transfer to:

10. CLOSING DATE

10.1 Please submit your duly completed entries together with the entry fees to PRAP secretariat before or latest by **5.00pm, 21 June 2018 (Wednesday)**. Late entries will not be entertained.

11. ENTRIES

- 11.1 Softcopy of entries in Hy-Tek format can be submitted via the Hy-Tek Team Manager software or Hy-Tek's Team Manager Lite for Swimming software and to be emailed to asap.prap@gmail.com. The event file for import into the Hy-Tek Team Manager is as enclosed.
- 11.2 For those who do not own the Hy-Tek Team Manager software can download Hy-Tek's Team Manager Lite for Swimming software from https://hytek.active.com/downloads.html.

12. EVENTS SCRATCHING / PENALTY

- 12.1 Scratching of events are allowed at Team Managers' meeting only. A penalty of RM25 per event shall be imposed for each event withdrawn (WDR) on the day of the Competition or for No Show (NS) or Did Not Swim (DNS).
- 12.2 If withdrawal is due to medical reason, a medical certificate must be furnished.

 A swimmer is deemed to be unfit to swim for the rest of the day on presentation of a medical certificates.

13. RESULTS

13.1 Official swim results will be posted on the board at the pool deck and will be emailed to all participating affiliates after the Competition. No hard copy of the results will be made available.

14. AWARD

14.1 Medals and/or achievement certificates will be awarded to swimmers who obtained top 3 positions. Each participant will be awarded Certificate of Participation.

15. TEAM MANAGERS' MEETING

15.1 Team Managers' Meeting is scheduled to be held at Akuatik Amanjaya Perak Darul Ridzuan's meeting room on **Thursday, 19**th **July 2018** at **5.30pm**.

16. PROTESTS

- 16.1 Protest are allowed against the decision of Referee. Protest must be submitted in writing by Team Manager to the Referee within 30 minutes of the display of official results, accompanied with a deposit of RM200.00. If the Referee rejects the protest, he/she must state the reasons for the decision. The Team Manager may then appeal the rejection of the Jury of Appeal, whose decision shall be final.
- 16.2 If the protect is rejected, the deposit shall be forfeited by the Organizing Committee. If the protest is upheld, the deposit shall be returned.

17. JURY OF APPEAL

17.1 Jury of Appeal shall comprise of three (3) members from the Organizing Committee and two (2) Team Managers from participating clubs not involved in the Appeal.
